1. Preliminary Remarks

- The operator of a plate brake tester is obliged to perform routine maintenance before the initial start-up and at intervals of 1 year. The routine tests must be performed only by a qualified service partner!
- In order to maintain the functionality throughout the whole life of the plate brake tester, maintenance in accordance with our recommendations in the service manual is required.
- Records of regular maintenance must be kept for at least 5 years.
- This maintenance book serves as a record/evidence of performed maintenance.
- A maintenance log is required for each device

2. Safety and Accident Prevention

Instructions in the operation manual should be followed carefully to avoid accidents and damage to the system. The plate brake tester may be used only for its intended purpose.

During the test procedure it is necessary to make sure that nobody is in proximity of the entire operating range. This applies to the rear, front and sides of the plate brake tester. Appropriate barriers or color markers (warning paint) around the test area should be attached to the floor.

- The operation manual must be followed
- All parts of the electrical system must be protected from moisture and humidity
- Maintenance and repairs may only be performed by qualified service partners
